One thing is clear—the Trump conviction shows what happens when unreasonable and wicked men and women set themselves above the LAW.

Even CNN legal analysts are saying, and I quote, "Merchan violated the Constitution." Zelin, one of CNN's Legal Analysts, said, and I quote: "I hate to do this, but I would be remiss if I didn't. Whether you are driving in a Ford or a Ferrari, if someone gives you bad directions, you're going to end up lost. And those jury instructions were just a complete, just-take-the-Constitution-throw-it-out-a-window-burn-it-shoot-it-and-hang-it."

Yeah, I'd say that about covers it! First, Bragg invents a crime for which there is no clear statute. Let me explain! New York has a law that you can't commit a crime that was done in order to commit a crime. But you don't have to PROVE he committed the crime he was trying to commit with the crime he committed, just prove, sort of, that he committed the crime you allege he committed to commit the crime. So if you are, say, committing a crime of speeding, but. you want to convict the speeder for, say, murder, you say he committed the crime of speeding in the effort to commit the murder — but by connecting the two things together, all the jury has to do is find him guilty of speeding, and not have a unanimous verdict on the charge that he was speeding in order to commit murder. That way, you can put a guy in the electric chair by building a case that satisfies a jury that he was speeding without having to be unanimous on the charge that he committed murder in the first place.<sup>3</sup>

You understand that Bragg never proved Trump personally ordered the payment of the hush money. He never even proved that

whatever evidence of manipulation of business records he put in front of the jury was done by Trump or under his orders. The entire case was circumstantial. But with a biased jury, he was evidently able to get a unanimous agreement that, yeah, Trump probably did that. And the Jury was not warned against rendering a guilty verdict on what they think Trump "probably did."

But Merchan and Bragg knew they could not get a unanimous verdict on the charge that the crime of paying hush money (which is NOT A CRIME) or falsifying business records (which is NOT A CRIME) unless it can be proved it was done in order to commit an actual crime under STATUTE, in this case, to interfere with an election.

This idiot judge instructed the jury that they could render a verdict of guilty even if they were not unanimous on the charge. That would be the only actual crime in the case: election interference. Which is another thing! What Biden is doing is blatant election interference—abusing the law to remove a candidate from running for office.

Anyway, the Jury was given convoluted instructions, not written out, that were long, confusing, and a tangled mess. The Jury was led to believe they could render a guilty verdict if they believed Trump paid the hush money or manipulated business records, even if they were not so sure he did it to interfere with an election.

But the only actual crime in this case was election interference. Even if he did prove Trump paid the hush money, and even if they proved Trump personally manipulated the business records — that does not prove he did it to interfere with any New York election. By relieving the State from the burden of PROOF, the Jury was led to believe they could render a guilty verdict on all counts, even if they were not unanimous on the matter of election interference.

So now New York is primed to lay on Trump the penalty of violating their election interference statute by a jury verdict that is not in unanimous agreement on that charge. [IBID]. FoxNEW's

legal analyst Gregg Jarrett said Bragg made "factually impossible" arguments against Trump. Friend, this is legal abuse!

This case was not done lawfully. The judge violated so many rules of law that it is almost certain to be a case study in law school examining ways the government can get it wrong for years to come. A case study on what happens when the institutions charged with dispensing justice come under the power of LAWLESS people. Bragg is a lawless man. Merchan is a lawless man. "Law is not made for a righteous man, but for the lawless and disobedient, for the ungodly and for sinners, for unholy and profane" (1 Timothy 1:9). Bragg, Biden, Merchan — repent! Like the CNN's legal analyst, Zelin, said: you have thrown out the Constitution — which is THE LAW OF THE LAND! Your conduct is unbecoming your office, and I call on you to resign! Haha! Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church belfry arch, signaling the enemy is on the march, an enemy that would steal from us our liberty.

Some are saying the Trump conviction means "justice has died" in America!

I understand feeling that way, but I'll explain why that is never true. When we see what's going on with the J6 political prisoners and Trump, we wonder, where is Justice. I can answer that!

Isaiah 59:14 And judgment is turned away backward, and justice standeth afar off: for truth is fallen in the street, and equity cannot enter.

Justice might be standing far off from us, but she is most definitely NOT DEAD! I'll explain what we must do to get her attention!

First, TRUTH must be taken up out of the street and set back on it's Pillar.

Second, judgment must turn its face toward us and not its back.

Third, justice must move back in to our culture.

How do we get TRUTH up out of the street where it has fallen?

Learning brings knowledge, but not TRUTH. Pilate asked Jesus, "what is truth?" He had asked Jesus whether or not He was a King. Jesus answered: "Thou sayest that I am a king. To this end was I born, and for this cause came I into the world, that I should bear witness unto the truth. Every one that is of the truth heareth my voice" (John 18:37). That's when Pilate said, "What is truth?"

He was not asking a question; Pilate was making a statement.

Where do you go to get TRUTH? Jesus came to "bear witness to the truth" — what did He say about it?

He made two very important declarations that together answer this question.

First, He said, "I AM THE WAY, THE TRUTH, AND THE LIFE, NO AN COMETH UNTO THE FATHER BUT BY ME" (John 14:6). Jesus said He was the Truth! Get Him right, and you've got the TRUTH.

The second thing He said about truth He said toward the conclusion of His physical presence in the world. When praying

for His disciples then, and future, He asked the Father to "Sanctify them through thy TRUTH, THY WORD IS TRUTH" (John 17:17).

Jesus is the WORD, the WORD WAS MADE FLESH AND DWELT AMONG US, AND WE BEHELD HIS GLORY, THE GLORY AS OF THE ONLY BEGOTTEN OF THE FATHER — HERE YOU GO — FULL OF GRACE AND TRUTH" (John 1:1, 14).

So, JESUS bore witness of the TRUTH, He told us that He is the TRUTH, His SPIRIT, or His BREATH, is the SPIRIT OF TRUTH (John 14:17; 15:26; 16:13), His SPIRIT breathed into the Scripture (the BIBLE) the words that reveal the TRUTH — 2 Timothy 3:16 — this is the WORD OF TRUTH — and the WORD OF TRUTH declares the GOSPEL of YOUR SALVATION (Ephesians 1:13).

Pilate could not figure out what TRUTH was because he refused the testimony that Jesus gave him.

This is the reason men can be "ever learning but never able to come to the knowledge of the TRUTH (2 Timothy 3:7).

TRUTH begins with CHRIST, and proceeds from there into His WORD — and the beginning of truth is when you receive the "word of truth, the gospel of your salvation."
