Media's focus seems to be the usual: eliminating second amendment protections is the "cure" and politicizing the event: in this case, lying about a statement by Vance that school shootings are a "fact of life."! anyway and work this through the courts, exhausting all avenues of appeal (LoL).

Why does he decide now? He claims it's because there are implications in the SCOTUS immunity ruling that he needs to consider. Merchan allowed testimony to be used in obtaining the jury's 34-count guilty verdict that would be disqualified under the SCOTUS Immunity ruling. Okay, but he has known that for more than two months! Trump's lawyers have brought this to the attention of the court almost from the beginning of the case. He claims the evidence in question was not critical to their case, and yet they insisted on allowing in against the objections of Trump's defense attorneys, who pointed out that the immunity question was before the court — it stands to reason that if the evidence was not critical to Bragg's case, why potentially jeopardize the entire case with unnecessary evidence. The fact is, the evidence was critical to Bragg's case, just like Trump's attorneys argued long ago.

Mr. Biase tells us Bragg “was just stacking charges and rearranging things” to fit a case he was trying to create against Trump. He expressed the opinion that it’s motivated entirely by politics and Bragg’s ambition to advance his career. Mr Biase calls what Bragg’s did “a perversion of justice,” a “travesty of justice,” and a “mockery of justice,” and says, “the whole thing is disgusting.”⁹

I brought out something in the Brain Massage® LIVE podcast on Thursday that I want my radio audience to hear. I’ll summarize it here. Isaiah 32:5 says “The vile person shall be no more called liberal, nor the churl said to be bountiful.” The word *vile* means perverse, corrupted, ruined — vile! The word *liberal* is a good word and speaks to one’s generosity and largeness of mind and spirit — an open-handed sort who wishes all men well. The “goodwill toward men” type. It is a mockery against GOD to call vile men liberal. God hates it! He will correct it!

Isaiah’s promise that the vile person will no longer be called liberal is both an implied and an express prophecy! The implied prophecy is that people will call the vile liberal. That’s what’s happening today! The most vile lying scoundrels will describe themselves as liberal. The expressed prophecy is that this will not continue; it will be stopped. Who are these vile people, these perverted souls that distort justice?

Today’s Liberal rejects the Bible as an authority in their lives and will not define righteousness and wickedness, good and evil, by the Bible. They define it by LAW. Law is to the liberal what the Bible is to us.

Righteousness and wickedness, good and evil are categories defined by legislatures, rulers, by human reason untethered to God’s WORD, and even untethered to reality itself — not subject to the laws of nature or of nature’s GOD.

Disconnected from biblical authority, they exalt “LAW” above the BIBLE, above GOD, and since law is created by men, they view similarly to how many Christians view the Bible.

If you’ve been with us for a while, you’ve heard me say virtually every evil in the world started in Christ’s churches, among His people.

Segment.02 Hello. Welcome back! I’m Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere’s lantern lighter, lighting the lamps in the church belfry arch, signaling the enemy is on the march, an enemy that would steal from us our liberty.

The Democrats are willing to violate every principle of true Democracy to protect their version of Democracy. I think what they call Democracy is whatever protects their hold on power over the people.

Attorney General Merrick Garland is very concerned about our Democracy, and he and FBI Director Liar Wray have vowed to take seriously every threat against it!

But they have a very strange understanding of Democracy. The only element of democracy in our system of governance is the right of the people to choose their rulers. I’m preaching on that subject tomorrow in the Lighthouse Pulpit: the Ninth and Tenth Amendments as protections of the principle that the power is owned by the PEOPLE and delegated by them to representatives.

CA has extended the principle of democratic rule by direct democracy, where the people initiate and vote directly on Legislatively referred statutes and amendments, initiate statutes

directly or indirectly, initiate amendments directly, veto the Governor, and recall the Governor — we are one of only about five states that provide a full spectrum of direct democracy, something I intend to make much use of. This allows for the people to gather sufficient signatures in support of a popular initiative or proposition and get it on the ballot—if the California voters pass the proposition, it becomes the law of our land. That’s how we got Proposition 13 — something our current majority in the Assembly, Senate, and our current occupier of the Governor’s mansion HATE and try every day to overcome.

But it’s the DEMOCRATS that oppose direct democracy — when the Voters decided that marriage would be defined, for legal purposes, as one man with one woman, Newsome, then Mayor of Frisco, defied the PEOPLE went straight to the Recorder office and began handing out marriage certificates to same-sex couples.
