They considered him weak and compromised because they had this “thing” to hang over his head and, as Johnson said, he has had no experience handling the intricacies of the office of the Attorney General. Many upper-level Dem strategists figured Gaetz would likely bungle about in unfamiliar territory and make mistakes they could exploit to slow him down. But now, Johnson warned, Bondi is more dangerous because she knows how to do this job; she’s “competent.” That scares them even more!<sup>4</sup>

Some think it’s possible Trump played this knowing who his second pick would be and that, in some ways, she would be an even better pick since, in fact, she has had career experience in the position of Attorney General. Her loyalty to Trump is solid, and we know she is a fighter; I remember her pressers while representing Trump in his first impeachment!

Bondi has some things to deal with, including rogue prosecutors who need to be brought to justice: Jack Smith, Letitia James, Alvin Bragg, and Fani Willis — all of them maliciously participated in the weaponization of the legal system to take out a political opponent — to use the “sword” of justice to pursue an unjust assault on an American citizen who posed a threat to them politically! I wonder what she is going to do about this. She will have to install policies supported by serious consequences for violation to protect against the weaponization of the DOJ in the future—she needs to look past her own term of office.

She might have to send arrest warrants out against Wray and Myorkas. I'm not talking about the arrogant nose-snubbing of the Senate;<sup>5</sup> that would be their job, but Schumer only pushes for that when it's MAGA Americans who refuse an illegal subpoena like Bannon. Schumer does not support the Senate's power of subpoena when it's legal and for inquiry into matters related to the security of this country. So Schumer's Senate postponed hearings on the national security threats posed by porous borders because Myorkas and Wray have defied them. We've got to break up the "good ole boy clubs" controlling Washington.

million), and Romney (3.3 million).<sup>7</sup> Big Pharma owns these yahoos!

RFK has a lot to deal with. As head of Health And Human Services, he has told us he will be focused on making Americans healthy again, and he has been talking about the junk American processed food companies load into our cereals and other consumables. Will he also break the FDA effort to build walls between us and Ivermectin? serious heart failure concerns.<sup>10</sup> Well, maybe he'll send him a "Get Well," card!

But, how about this news: "One of the most heavily vaxxed counties in America is now facing a heart attack crisis." Are you ready for this? I think you'd better sit down. "98% of people in King County, WA (Seattle) took at least one COVID shot, and the data is not looking good. A peer-reviewed study has found a jaw-dropping 1,236% surge in excess heart attack deaths among King County's 2.2 million residents." enemy is on the march, an enemy that would steal from us our liberty.

I intended to show how the Trump picks converge together to create a phalanx—moving in close formation against the Deep State. The problems that need to be addressed will involve a coordinated effort on the part of Hegseth over the DoD reigning in the Pentagon, RFK over Health and Human Services, Elon and Vivek providing very intense pressure on all departments to get in line, Bondi wielding the domestic sword of justice with Hegseth wielding the national sword—and the other picks as well. Please pray because the appointment of even one Judas can undermine the swamp-draining that needs to be done.

I think I have time to address JD Vance's support for a Convention of States. I have been on record as opposing this, and I continue to have some reservations. But I looked more deeply into this issue and I'm beginning to think it might be the only way forward—the resistance to Trump's picks is opening my eyes to a critical issue that I think must be in place to justify calling for a Convention of the States to bypass Congress and submit to the People amendments to the Constitution that our Congress will even bring before the People. The Congress does not represent the voters any longer — they've become a "good ole boy club" and like I said in the first segment, they get absorbed into the PARTY POLITICS game like a sailor becomes part of the Flying Dutchman. Let's look at this!

I'm responding to a report that JD Vance is the first VP to support invoking an Article V - Convention of States.

I've read the "Pocket Guide" published by COSA - Convention of States Action. I have always been in full sympathy with the concerns expressed but felt that tampering with the Constitution in this way required a circumstance where it is clear the majority of Americans are in full support of LIBERTY. But having read more



deeply into this matter, while I have some concerns that I'll mention in a moment, I totally understand the reason a Convention of the States is felt necessary by many of our conservative heroes.

Let's begin with what Article V says:

“The Congress, whenever two thirds of both Houses shall deem it necessary, shall propose Amendments to this Constitution, or, on the Application of the Legislatures of two thirds of the several States, shall call a Convention for proposing Amendments, which, in either Case, shall be valid to all Intents and Purposes, as Part of this Constitution, when ratified by the Legislatures of three fourths of the several States, or by Conventions in three fourths thereof, as the one or the other Mode of Ratification may be proposed by the Congress; Provided that no Amendment which may be made prior to the Year One thousand eight hundred and eight shall in any Manner affect the first and fourth Clauses in the Ninth Section of the first Article; and that no State, without its Consent, shall be deprived of its equal Suffrage in the Senate.”

My concerns, however, related to some of the safeguards those advocating for invoking Article V assume—namely, the convention will be limited to propose amendments in line with the topics stipulated in the application to Congress.

The language actually only requires two thirds of the State's legislatures to “call a Convention for proposing Amendments.” Nothing is actually said about limiting the Convention to only the topics stipulated in the call for the Convention.

Advocates point to precedent, but even in their examples, especially the first one, the topics to be addressed, it seems to me, were not strictly limiting. We all know how “lawyers” read into language and squeeze and twist meaning out of language that shocks a person with common sense and clouds and confuses the ignorant. This is the reason I always insisted back in the 90s would have been a bad

time to invoke Article V, but with the Red Wave, it does appear to be more likely to do some good.

One can legitimately argue that the language of Article V means the amendments desired are to be stipulated with limitations to topics presented in the application to Congress, and that is in agreement with precedent.

And, I think the idea that 2/3 of states would agree together to an open-ended amendment process is unlikely to the point of impossible. Now, in fact, might be the best time to open this up!

The reason it's needed is that the Congress has failed. How many times have we won in the Ballot box only to LOSE in Congress because, mostly, Republicans simply, it seems, “don't know how to act when they win; they don't know how to wield power when we give it to them — over and over again we've felt betrayed by our Republican Representatives and Senators — it's like we send them to Congress and they become absorbed into the “good ole boy” club and start Representing each other, and covering for each other — or they get corrupted and come under the control of the Deep State operators. This is exactly the circumstance that requires invoking that provision in Article V that allows us to bypass Congress to amend the Constitution.

As Congress is currently constituted, neither Chamber can be trusted to be responsive to the people's voice expressed through the ballot. We are witnessing this right now with the Republican resistance to getting behind MAGA. I object to much in this little book and will make my objections known more clearly in future. However, the primary concerns I have had are adequately addressed in this PDF booklet, and I recommend it to you. Here is the link where you can get it.<sup>14</sup>

The need for the Convention is critical, so let me reiterate: I think it's true the current buddy system in Congress is constructed around supporting that system, that Representatives, generally, are committed to "having the backs" of their fellows in Congress: they are willing the STAB THE BACKS of the voters to protect the backs of their Party BUDDIES. That is mostly because the promotion and advancement of political careers are greatly controlled by the Party Bosses. The stabbing of Gaetz comes to mind! Therefore, this list of amendments will likely NEVER make it through Congress as proposed amendments without a convention of States, and they are needed:

1. Limit Supreme Court Justices to nine members.
2. Prevent the addition of states without the affirmative consent of three quarters of the existing states.
3. Require members of Congress to live under the same laws they pass for the rest of us,
4. impose term limits on members of Congress.
5. Require a balanced federal budget.
6. Impose limits on federal spending and/or taxation.
7. Get the federal government out of our healthcare system.
8. Get the federal government out of our education system.
9. Stop unelected federal bureaucrats from imposing regulations.
10. Set term limits for Supreme Court Justices.
11. Set term limits for federal bureaucrats, ending the dominance of the swamp.
12. Remove authority of the federal government over state energy policy.
13. Force the federal government to honor its commitment to return federal lands to the states.

These are from COSA (Convention Of States Action).

I would add a sanctity of LIFE amendment and protection against any law that facilitates child mutilation or sexualization by adults, with a mandatory DEATH PENALTY against any who exploit children or women, or men in slavery or sexual exploitation.

A prohibition against making laws redefining gender roles and marriage, and provide for criminal prosecution of any public official convicted of tampering with the sanctity of the vote of the people in State or Federal elections, and criminal prosecution of anyone holding public office who uses that office to advance an agenda violating any Constitutionally protected rights of the American people.

Such abuses of power MUST be a matter of criminal prosecution for any public official to act contrary to the law of the land, and in particular, to act in a manner that encroaches upon the Constitutional Rights of Americans to CONSENT to who represents them, and any other right that as stipulated in the Constitution as understood within the context of original intent.

That means anyone proposing a LAW that encroaches upon our First through Tenth Amendments should be immediately removed from office and never allowed to hold any office of public trust from thenceforward. Why? Because this is a VIOLATION OF THEIR OATH OF OFFICE THAT WE REQUIRES OF PUBLIC OFFICIALS.

However, with all of that, in the end, bad men will find ways to distort and pervert the LAW and contrive to create ways to circumvent the will of the people, and so vigilance and diligence are essential — and TRANSPARENCY is the KEY — which is why I love what Elon and Vivek are doing.

THE PRIMARY THING I'VE WONDERED ABOUT WITH THOSE CALLING FOR A CONVENTION OF STATES IS WHY

THEY THINK AMERICANS WILL SUPPORT THEIR AMENDMENTS IF THEY REFUSE TO ACCEPT THOSE OF THE FOUNDERS.
