First, what is an “unconditional discharge” sentence?⁸ Simply, it means the person charged is found guilty, but the court does not impose any penalties. It’s usually reserved for cases where the prosecution sees no point in penalties either because the nature of the charges is insufficient to warrant any or because of some other mitigating circumstance that makes charges either unnecessary or inappropriate.

Actually, so far as I can find, Merchan did not explain the basis for this. Given that his intentions were floated in public in advance, I think it was because he got what he and Bragg wanted—this completely satisfied the purpose of the prosecution, and it’s all they expected to get out of it — to hang a felony charge on Trump before he takes office on Jan. 20. Because they are legalists, they consider “getting a conviction” is de facto guilt. It’s their de jure entitlement to insist he is “guilty” as charged because the court said so! But there are a whole lot of Americans who see right through this. Guilt is not something a court can manufacture — such an egregious effrontery to justice cannot long be ignored by GOD — and the American people watched this charade, and they know it’s bogus.

I’ve read the sentence, and in my opinion, it’s a carefully constructed LIE. You understand this case, right? Here is a Cliff’s Notes version: (The best authoritative concise explanation I’ve found is available at this link.⁹) I’ll summarize it here: AG Bragg pressed a charge for an action that was beyond the statute of limitations. In other words, even if the deed was a crime, and it

wasn't, but if it was a misdemeanor and it was beyond the reach of the Law.

Second, Bragg manufactured a crime to fit the deed! Get that? He crafted a law to make something illegal that had NEVER BEEN TRIED IN ANY COURT EVER.

We point to the similarities between this sympathetic framing of MAPs and the political goals of the pro-pedophile advocacy groups that created the term MAPs, and from which many MAPs studies recruit their research participants. The review concludes that, in the absence of adequate self-reflexivity and awareness of bias, academic collaborations with pro-pedophile groups can produce work that minimizes the risk and harm of child sexual abuse and has the potential to delegitimize child sexual abuse prevention and treatment efforts.” NOTE: This article does not support the use of MAPs to provide cover for child sexual abuse. It’s actually a helpful expose and explanation of the effort to “normalize” pedophilia.
